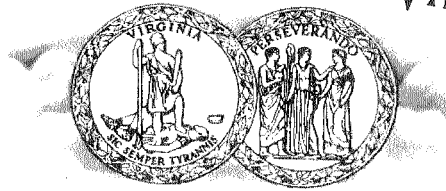

Form 8. Bond for Costs Alone - Required by Supreme Court on Appeal of Right From State Corporation Commission.

KNOW ALL MEN BY THESE PRESENTS, That I, Douglas Robert Johnson, principal, and CASHIER'S CHECK, surety, are held and firmly bound unto the State Corporation Commission, the County of Fluvanna, the County of Louisa, and the James River Water Authority, appellees, in the sum of Five Hundred Dollars (\$500.00) to the payment of which we bind ourselves, our heirs, successors, personal representatives and assigns, jointly and severally, firmly by these presents.

The condition of this obligation is such that:

Whereas the Supreme Court of Virginia on the 13th day of October, 2009, awarded an appeal from a final order entered in Case No. 091703 under the style of CLK-2009-00014 by the State Corporation Commission of Virginia, on the 21st day of April, 2009, on the condition that appellant Douglas Robert Johnson or someone for him, file an appeal bond with sufficient security in the clerk's office of the State Corporation Commission, in the penalty of Five Hundred Dollars (\$500.00) within fifteen (15) days of the date of the certificate of appeal, with condition as the law directs;

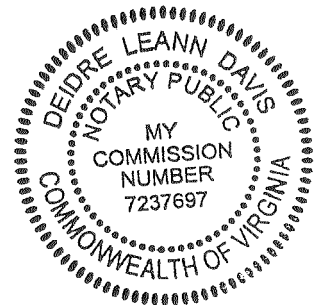
